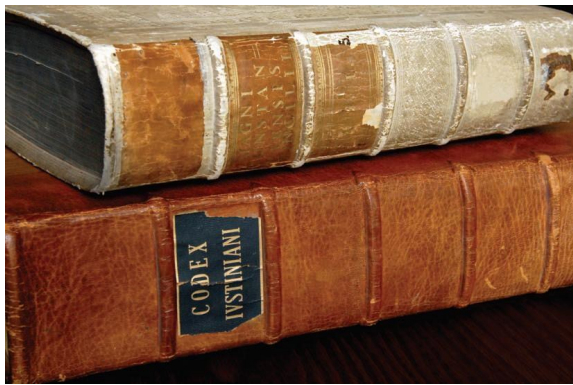

On September 8, 2015, Pope Francis had his motu proprios *Mitis iudex Dominus Iesus* and *Mitis et misericors Iesus* presented to the world. The new legislation, effective December 8, 2015, changed the procedural norms for the declaration of nullity of marriages. In addition to the existing and now modified ordinary procedure, a new *processus brevior* was introduced.

The 2016 Spring Canonical Seminar, offered by the School of Canon Law in collaboration with the Committee on Canonical Affairs and Church Governance of the United States Conference of Catholic Bishops, aims at giving assistance and guidance to practitioners and their Bishops in applying the modified and new legislation.

Four presentations are offered, each aimed at a particular aspect of the modified or new legislation. First, the role of the diocesan Bishop in the marriage nullity procedures will be explained and

highlighted. Two presentations will focus on the procedural norms: one on the modified ordinary process, a second on the new *processus brevior*. The last presentation will offer needed help with the jurisprudential issues raised by the new legislation.

The 2016 Spring Canonical Seminar is the latest in a series of annual workshops presented by the faculty of the School of Canon Law of The Catholic University of America to foster better working knowledge of the Code of Canon Law and its practical implementation in the life of the local Church.
